
The Children

CASA served 167 children in FY 2021, which equates to 50% of the 335 children from Middlesex County who were in foster care during that time. This represents a 6% increase from the number of children served during the prior year.









Major Fundraisers


Holiday Ask: The Holiday Ask raised \$20,454.

The Volunteers

CASA worked with 88 volunteers appointed to 167 children during the year. Volunteers donated a total of 4,618 case-related hours valued at \$145,051. They also drove 9,792 miles to visit children and gather information about them.

Devon and Deja Stay Connected



Devon and Deja are siblings who have spent over half of their childhoods in the child welfare system. While much of that time was spent apart, and each child was adopted by a different family, the children have maintained their connection, in part through the advocacy of their CASA volunteer, Audre.

When Audre noticed that Devon had taught himself the keyboard from YouTube videos, she advocated for him to receive piano lessons. Similarly, while Audre was not always able to stop Deja from being moved into different resource homes, as many as five in one year, she was able to successfully advocate for Deja to stay in the same school.

The siblings remained connected first through visitations, advocated for by Audre and strongly supported by the judge. Eventually, the siblings' adoptive families spent time together as well. This continues up to this year, when Devon spent the night of Christmas Eve with Deja's adoptive family, allowing the two to spend Christmas together for the first time in years
