


# The Children

CASA served 190 children in FY 2024, which equates to 68% of the 281 children from Middlesex County who were in foster care during that time.


## Race of Children




## Ethnic Origin of Children

# Major Fundraisers


**Toast:** The Toast, honoring Dianne Roman, Sayreville School District and Betsy Goor raised **\$55,183**.

# The Volunteers

CASA worked with 73 volunteers appointed to 190 children during the year. Volunteers donated a total of 4,752 case-related hours valued at \$168,696. They also drove 22,177 miles to visit children and gather information about them.

# FY2023 Impact Highlights

- CASA represented **190** children in Court
- **93%** of CASA's recommendations were accepted by the Court
- CASA serves all **20+ communities** in Middlesex County, New Jersey
- CASA of Middlesex County is part of a national association of nearly **1,000 CASA programs**
- As of June 30, 2024, CASA reached **68%** of Middlesex County youth in foster care

## A few words from our volunteers

“CASA’s presence demonstrates, to children, parents, judges, and counsel, how invested we are in advocating for the children’s best interests. It also provides the judge an opportunity to solicit additional input from CASA during court hearings. There were several times that my advocacy efforts resulted in some really meaningful outcomes for the children. Some of them were simple, like ensuring that new glasses were provided to the child. Others are a little more complex, like soliciting input from a teacher regarding the child’s needs and then using that information to address those needs.”

# Destiny's Story



When Destiny was born, she tested positive for illicit drugs and suffered from symptoms of withdrawal throughout her time in the NICU. Due to her mother's substance abuse issues, when Destiny was ready to be discharged, she was placed with her great grandmother. CASA Bridget was assigned the case.

Recognizing the fragility of Destiny's condition, Bridget was sure to make recommendations to the family court judge that centered on wellness visits to the doctor, follow ups with important specialists and a referral for early intervention as soon as possible. During one of her visits with Destiny when she was 7 months old, CASA Bridget noticed the baby was having issues with her eyes. She was able to bring this issue to the court right

away in her report and recommend a visit to a pediatric ophthalmologist.

Throughout the course of Destiny's time with her great grandmother, the Division of Child Protection and Permanency had been looking for alternative placement options in the family. This was because Destiny's great grandmother was not able to care for her long term. When Destiny was placed with her aunt, CASA Bridget was instrumental in communicating with both parties and ensuring that none of Destiny's health needs slipped through the cracks.

CASA Bridget continued to follow up with Destiny in her new placement, to ensure all her needs were being met. Important recommendations such as neurological evaluations, follow ups on Destiny's eye condition (which she eventually had surgery to correct) and the continuation of much needed early intervention services, were consistently noted in her reports to the court. When Destiny was two years old, she was adopted by her aunt.
